1. Introduction

- 1.1 These Terms and Conditions ("Terms") govern the provision of retreats ("Retreat") by Bravura Retreats, a division of Zing Performance Ltd ("we", "us", "our"). By booking a Retreat, you agree to comply with these Terms.
- 1.2 These Terms, together with our Privacy Policy, form the entire agreement between you ("you" or "Guest") and us and supersede any prior agreements.

2. Retreat Information

- 2.1 Details about the Retreat, including location, services, and pricing, are available on our website **www.bravura- retreats.com**.
- 2.2 Bravura Retreats reserves the right to make reasonable changes to the Retreat schedule, location, or content as needed to enhance the guest experience.

3. Booking and Payment

3.1 **Securing Your Place**: To secure your place, a 20% reservation fee is required, unless booking is within 30 days of

the retreat, in which full payment is required. This fee is nonrefundable except where the Retreat is cancelled by us.

- 3.2 **Full Payment**: Full payment must be made no later than 30 days before the Retreat start date. Failure to pay in full may result in cancellation of your booking, with all fees forfeited.
- 3.3 **Booking Confirmation**: Your booking is confirmed when you receive a Booking Confirmation email. If we decline your booking for any reason, any payment received will be refunded in full.

4. Cancellations and Refunds

4.1 **14-Day Cooling-Off Period**: You may cancel your booking within 14 days of receiving your Booking Confirmation and receive a full refund, provided no services have been delivered during this period.

4.2 Cancellations After 14 Days:

- Cancellations made more than six weeks before the Retreat: Eligible for a 50% refund (excluding the reservation fee).
- Cancellations made less than six weeks before the Retreat: No refunds will be issued.
- 4.3 Refunds will not be issued for non-attendance or partial participation.

5. What's Included

- 5.1 The Retreat includes accommodation, meals, and activities as specified on the website. Travel, insurance, and any additional costs are not included unless explicitly stated.
- 5.2 Dietary and medical requirements must be communicated at the time of booking to ensure your needs are accommodated.
